Treatment of water milfoil in Long Lake reported. 6.7 acres were treated.

Motion by Zirnhelt, Berg seconded, to treat water milfoil in Ruth Lake upon approval of necessary riparian owners. Motion passed.

Rundio will resign from township's Parks and Recreation Committee; Cartwright will represent the Board hereafter.

f. Water Safety: Kraimer.

Sheriff's office will continue providing lake patrols.

No evidence of gill net fishing on Long Lake.

Picnic Island work 95% complete.

- a. Zoning: Kiehle reported on the work of the Planning Commission concerning lakeside structures. He and Cartwright to formulate a recommendation to the Commission for Board approval.
- b. Increasing membership: Discussion of need and means of increasing membership.

- c. Website:
 - Motion by Rundio, Zirnhelt seconded, to remove from website outdated material entitled "Management of Eurasian Water Milfoil."
 - Motion by Cartwright, Templeton seconded, to table motion to remove from website outdated material entitled "Management of Eurasian Water Milfoil." Motion failed. Cartwright abstained.
 - Main Motion to remove current website page entitled "Management of Eurasian Water Milfoil" discussed. Motion passed.
 - Motion by Rundio, Zirnhelt seconded, passed to remove current website page entitled "Long Lake Association Species Management Policy" and replace it with "Invasive Species Management Procedure. Each year the Lake Management committee will make a recommendation to the Board of Directors as to the preferred method(s) of treating any invasive species such as Eurasian Water Milfoil. The Board will be open to considering any method or combination of methods that are deemed environmentally and economically appropriate. The Board will vote to either accept, reject or modify the Lake Management Committee's recommendation for that year." Motion passed.
 - Motion by Zirnhelt, D. Marks seconded, to remove from current website the words "There is ongoing debate over the long term ecological and health risks."
- d. Insect spraying on islands. D. Marks reported it is only on the structures. Discussion meeting minutes to be altered to reflect that situation.
- e. Fireworks' effect on loons discussed. Zirnhelt to ask Balderach to research issue.
